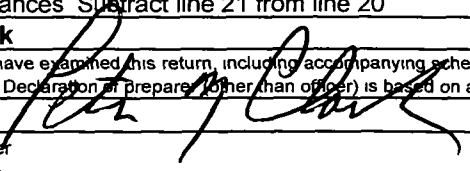

The Foundation provides scholarships for individuals with mental health issues to be able to attend the conference

Included among the grants the Foundation provides are those to groups of individuals who are currently in treatment for mental illness for basic needs and services to enhance the quality of their lives and aid in their recovery. The Foundation funds socialization activities such as outings and providing equipment for gardening, for individuals residing in government funded group homes
