Explanation: Dear Sir or Madam, I am writing to request relief from penalty for late filing due to an inadvertent failure to file for an automatic extension request for the annual 990 form for Life Line, Inc., a nonprofit crisis pregnancy center (EIN #52-1663986). I am a volunteer for the organization and have filed the 990s for them for the past 17 years. In every year, I have requested an extension until August 15th because my obligations to my minor children make it very difficult to complete all the necessary procedures for filing during the school year. This year was supposed to be just the same, and I had planned to file the extension request through efile.form990.org, as I had done in many previous years. However, my personal life has taken a very bad turn of late, and this spring found me preparing to move, sell a house, take on a second job and file for divorce from my husband of 28 years. In the chaos that characterized my life this spring, I nonetheless intended to file the extension, and put it on my schedule. I went to the crisis center several times this spring to complete bank reconciliations, help them with a data loss problem and assist in preparing their budget. I honestly thought that I had filed the extension as well. I had discussed it with the center's director and assured her that I would do so. In my stress and constant busyness, I thought I had filed it, just like in prior years. When I sat down to begin the filing two week ago and I found no extension recorded on the efile990.org, I was shocked and upset. I immediately tried to file an extension, but of course it was rejected. I really thought I had filed one, and spent two weeks digging through paper and electronic files, thinking that perhaps I had filed it from a different computer than usual or had typo-ed the EIN and misfiled. Eventually I was forced to reach the conclusion that I had simply forgotten, an admission no aging volunteer wishes to make. I am writing to beg for mercy on behalf of an excellent organization of devoted staff and volunteers who have delivered loving and faithful service to women confronted by unplanned pregnancy for many years. Their funding and services should not suffer due to my mistake. I would also like to make it completely clear that the center quite understandably relied upon me to do this, as I have done it for so many years. They had no reason to expect the required extension had not been filed, and therefore exercised reasonable care to comply with the law in this respect. Since the extension process does not require board or executive approval, but is typically completed by me on my own, they had no clue that the extension had not been filed, and I am entirely confident if they had suspected so, they would have taken immediate measures to make sure that it was done. They have now taken steps to have a staff member cross check my filing schedule to ensure that this cannot happen again. In requesting this, I wish to point out that our organization has filed timely and complete 990s in this same pattern for the past 17 years. Each year we requested the extension until August 15th, and each year we filed timely by that date. This year we will once again be filing by that date. The only thing different is that I forgot to file the extension. I respectfully request that our long history of voluntary and complete compliance be taken into account in considering whether to grant a retroactive extension or abate the late filing penalty. Thank you in advance for your thoughtful consideration of this request. I declare under penalty of perjury (under the laws of the United States of America) that the foregoing is true and correct.
