U-Turn continues to partner with Team Loaded, Own Touch/Futsal RVA, Onyx Elite, Hill City Church, Relationship Foundation (previously First Things First), RCLI, FCA, PAK Ministries, Jacob's Chance, and Global Frontier Missions. In partnership with these organizations, the U-TURN facility offers an environment where sports encourage fellowship, inspire leadership, and spread hope for the future of youth in the Richmond/Tri-City Area. In congruent with other programs, U-Turn's USPAV volleyball program, led by Don Gresham continues to be nationally ranked and recognized as one of the top club volleyball programs on the East Coast. U-TURN also provided summer volleyball program and a fall basketball leadership program that served over 100 volleyball students and 25 basketball students from the Richmond area. These programs provided the following components: Health/fitness, biblical guidance, character/leadership development, sports specific training, and team building.
