These items include small household items, clothes, shoes, sports equipment, bed linens, dishes, etc. The items are sorted and priced for resale. 16,786 bags of merchandise were given. Goodwill, Purple Heart, Salvation Army, and Veterans came to get what we could not use. Equipping the Scouts took 35,796 pounds of clothing (or 17.6 tons), 4 canes, 7 crutches (pair), shower chair, 4 walkers, wheel chair, 12 suitcases, 12 sports equipment and backpacks. Approximately 384 boxes of books were donated to Regional Library as well as 400 paperbacks. Merchandise donated by shop totaled \$7,636.16, making total book + merchandise \$11,676.16. Excluding the listed services above, the merchandise from the store included needy families, schools, churches, mission trips, and giving helping hands to others. We sell our gently used sports equipment to a sports store in Charlottesville since they can get a higher price than we can.

We feel blessed in our success as a business that has been in operation for almost 40 years. It has been divinely blessed for the good we are trying to do. We have become an important business the community of Crozet.

Our reserves are blessed to help us prepare for the need of relocation, possibly in the next 3 years.

Our entire volunteer staff believe in this mission.
