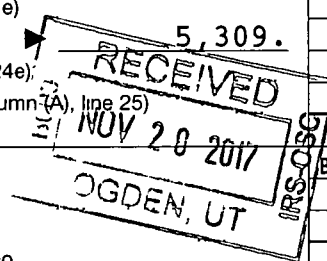

THIS IS THE LARGEST PRIDE FESTIVAL HELD IN VIRGINIA. THE PRIME WATERFRONT LOCATION IS EXEMPLIFIED BY THE ONLY PRIDE FESTIVAL BOAT PARADE HELD IN THE COUNTRY. THE FESTIVAL'S PRIMARY FOCUS IS TO INSTILL PRIDE IN THE LOCAL LGBT COMMUNITY AND ALLIES. THIS FOCUS IS ACHIEVED BY ENCOURAGING CELEBRATION, VISABILITY, AND SOCIALIZATION IN AN ACCEPTING ENVIRONMENT FOR ALL ATTENDEES. THE FESTIVAL INCLUDES A FAMILY AREA, LGBT HISTORY AREA, LGBT/ALLIED VENDOR BOOTH, LGBT/ALLIED NON-PROFIT BOOTHS, AND TWO ENTERTAINMENT STAGES WITH LOCAL AND INTERNATIONAL ENTERTAINMENT. IN ADDITION TO THIS ONE DAY EVENT, HAMPTON ROADS PRIDE ORGANIZES VARIOUS OTHER EVENTS DURING THE YEAR TO
