MSI SUPPORT - EXPANDING DELIVERY OF GLOBAL FAMILY PLANNING SERVICES IN LATIN AMERICA In 2016 MSI delivered services through approximately 225,000 client visits. MSI's program in Bolivia continued to expand access to contraception, particularly long-acting reversible and permanent methods. This was largely through the success of mobile outreach programs, which deliver services in some of the most remote communities in the country. MSI expanded its work to reach young people with reproductive health information in Bolivia. In Mexico, MSI continues to increase access by strengthening its clinic network, expanding its call center services, and providing training and capacity-building to reproductive health providers.
