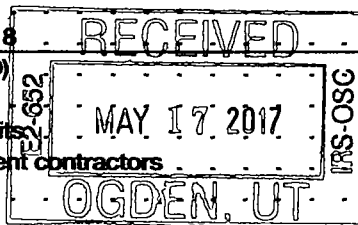

Part I Line 8 Other Revenue: FDR received \$45 from the Amazon Smile Foundation, which represents a percentage of the value of purchases made by shoppers who designate our organization to be the recipient of the benefit offered by Amazon.

Part I Line 10 Grants and similar amounts paid: During 2016, FDR provided \$52,811 for 20 projects in the Dominican Republic, all related to communities and programs recommended by Peace Corps Volunteers. Funding for 18 of the projects was made through the US-based Peace Corps Partnership Program. The vast majority of these grants supported small-scale infrastructure projects in rural, impoverished communities. The only activity not related to infrastructure projects is a very small pilot project we undertook in 2015 to provide university scholarships to two Dominican students to attend Dominican universities. These students had worked in youth programs sponsored by Peace Corps; the students both worked as well with student athletes from Virginia Tech who recommended them for the pilot university scholarship program.

Part I Line 16 Other Expenses: FDR incurred \$1061 in expenses for general expenses such as PayPal fees, the cost of web hosting and domain name maintenance, the annual fee to maintain our corporate status in Virginia, updates to our accounting software and similar administrative expenses.

Part I Line 20 Changes in Net Assets: This amount represents a net increase in our investments (almost exclusively mutual funds). This increase helps to offset the net loss we reported last year.
