In 2016, Augusta Health Foundation had its most successful year to date with more than \$950,000 in philanthropic support secured to support endowment, capital and programmatic needs of the health system. These gifts provided for patient care services and programs in the following areas: hospice, cancer, disaster response, emergency services, obstetrics, diabetes management, and the Medical Home. In addition, new technology-communications programs were developed for deaf and hard of hearing, AND a new medication assistance program was implemented for the uninsured and underinsured. Augusta Health's Board of Directors approved the renovation and expansion of the hospital's emergency department. The cost of the project is \$22 million. In June 2016, Augusta Health's Board approved \$20 million for the project from health system reserves and asked that the Foundation secure philanthropic funding of \$2 million. Following a comprehensive campaign assessment, the Augusta Health Foundation Board approved a \$2 million capital campaign. Special event revenue and early gifts were provided to support this critically-needed project.

Form 990, Part III, Line 4b:

The Shenandoah House is under the corporate umbrella of the Foundation and its financial data for 2016 are included within this form. The Shenandoah House is an assisted living facility where patients receive end-of-life care. In 2016, the Shenandoah House had 1,125 patient days and \$124,338 in uncompensated care to patients who could not afford care. THE ORGANIZATION OPERATED THE SHENANDOAH HOUSE IN FURTHERANCE OF ITS EXEMPT PURPOSE TO SUPPORT AUGUSTA HEALTH CARE, INC. THE SHENANDOAH HOUSE IS A BEAUTIFUL ASSISTED LIVING RESIDENCE NESTLED IN A TRANQUIL, WOODED AREA ON THE AUGUSTA HEALTH CAMPUS. IT IS DESIGNED FOR HOSPICE PATIENTS NO LONGER ABLE TO LIVE AT HOME WITHOUT ASSISTANCE OR WHO HAVE NO SUITABLE CAREGIVER AT HOME.
