THE ROANOKE CHAPTER OF THE NATIONAL RAILWAY HISTORICAL SOCIETY WAS CHARTERED ON JANUARY 11, 1968. IT IS A NON-PROFIT ORGANIZATION QUALIFIED UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE. THE CHAPTER'S PRIMARY MISSION IS TO PRESERVE, PROMOTE AND DISSEMINATE INFORMATION ABOUT THE HISTORY OF THE RAILROAD OPERATIONS IN THE WESTERN VIRGINIA AREA. AS PART OF THE MISSION TO PRESERVE, THE CHAPTER HAS ACQUIRED OVER THE YEARS SEVERAL LOCOMOTIVES AND A VARIETY OF HISTORICAL RAIL EQUIPMENT, INCLUDING FREIGHT CARS, CABOOSSES AND SERVICABLE PASSENGER EQUIPMENT WHICH IS PRESENTLY LEASED TO OTHERS FOR EXCURSION TRAIN OPERATIONS. THE PRESERVATION OF THIS EQUIPMENT IS VITAL TO THE COMMUNITY AND AREA HERITAGE. THE CHAPTER ALSO HAD A COLLECTION OF HISTORICAL DOCUMENTATION AND RAIL BOOKS. IT DONATED THESE HISTORICAL ARCHIVE RECORDS TO THE NORFOLK AND WESTERN HISTORICAL SOCIETY, A NON-RELATED 501(C)(3) ORGANIZATION, FOR THE ARCHIVAL STORAGE AND DISSEMINATION TO THE PUBLIC. THE ROANOKE CHAPTER, NRHS OWNS THE FORMER VIRGINIAN RAILWAY PASSENGER STATION BUILDING AND REAL ESTATE IN ROANOKE, VIRGINIA, BY DEED OF DONATION FROM NORFOLK SOUTHERN CORPORATION IN 2004, BEING RECORDED IN 2005. THE STATION WAS SEVERELY DAMAGED BY FIRE IN JANUARY 2001. THE CHAPTER IS ENGAGED IN THE JOINT PROJECT WITH THE ROANOKE VALLEY PRESERVATION FOUNDATION TO RESTORE THIS BUILDING WHICH IS ON THE NATIONAL REGISTER OF HISTORIC PLACES. GRANTS IN EXCESS OF \$1,250,000 HAVE BEEN AUTHORIZED WITH PAYMENT EXPECTED TO BE RECEIVED IN 2009 THROUGH 2015. PHASE I RESTORATION (BROWNFIELD ABATEMENT, BUILDING STABILIZATION AND ROOF REPLACEMENT) HAS BEEN SUBSTANTIALLY COMPLETED AT THE TIME OF THIS FILING. PHASE II (COMPLETION OF THE INTERIOR AND LANDSCAPING) SHOULD BE COMPLETED IN 2016. ON JANUARY 10, 2011, THE CHAPTER DONATED \$50,000 TO ITS VIRGINIAN RAILWAY STATION RESTORATION PROJECT AS PART OF THE CHAPTER'S MATCH OF GRANT FUNDS TO BE USED IN THE RESTORATION OF THE BUILDING WHICH IS ON THE FEDERAL AND STATE REGISTRIES OF HISTORICAL LANDMARKS. THE CHAPTER HAS ALSO DONATED OVER \$70,000 IN DONATED FUNDS TO THE VIRGINIAN STATION PROJECT. FROM 2009 TO 2012, THE CHAPTER RESUMED ITS SPONSORSHIP OF EXCURSION TRAIN RIDES FROM ROANOKE, THIS TIME TO BLUEFIELD, SHENANDOAH, ABINGTON, DANVILLE AND OTHER DESTINATIONS AND RETURN. IN 2015, THE CHAPTER PARTNERED WITH THE VIRGINIA MUSEUM OF TRANSPORTATION TO PROVIDE EXCURSION HOSTS AND FOOD SERVICE ON THE STEAM EXCURSIONS SPONSORED BY VMT USING THEIR FORMER N&W CLASS J STEAM LOCOMOTIVE #611. NET PROCEEDS RECEIVED BY THE CHAPTER WERE APPLIED TO PRESERVATION OF THE CHAPTER'S HISTORIC LOCOMOTIVES AND RAIL CARS AND TO THE VIRGINIA RAILWAY STATION RESTORATION PROJECT DESCRIBED ABOVE. THE CHAPTER AND THE VMT PLAN TO CONTINUE THEIR PARTNERSHIP AND OPERATE 5 MILE EXCURSION RIDES ON THE ROANOKE BELT LINE DONATED TO VMT BY NORFOLK SOUTHERN IN 2015. TO SUPPORT THIS FUTURE OPERATION, THE CHAPTER PURCHASED A FOUR-BAY GARAGE BUILDING AND REAL PROPERTY ADJACENT TO THE ROANOKE BELT LINE RAIL LINE IN 2011. THE CHAPTER ALSO RUNS SHORT (1 MILE ROUNDTRIP) TRAIN RIDES TO THE PUBLIC AT THE VIRGINIA MUSEUM OF TRANSPORTATION IN CONJUNCTION WITH VMT EVENTS.
