

FOR REPORTING PURPOSES, THESE TWO PROGRAMS ARE CONSOLIDATED, WITH THE FOSTER COMPONENT INCURRING THE EXPENSES AND THE ADOPTION PROGRAM GENERATING THE REVENUE. EXPENSES FOR THE FOSTER PROGRAM CONSIST PRIMARILY OF VETERINARIAN FEES (73%) WITH THE BALANCE SPENT ON BOARDING, DOG TRAINING, AND PET FOOD. HSLC BELIEVES THAT HELPING RESIDENTS OVERCOME TEMPORARY FINANCIAL SETBACKS IN SUCH A WAY THAT ENABLES A PET TO STAY LOVING HOME REDUCES INTAKE AT THE COUNTY FACILITY, WHICH IN TURN REDUCES THE EUTHANASIA RATE AND TAXPAYER LIABILITY. IN 2016, HSLC ASSISTED 37 FAMILIES THROUGH THIS PROGRAM. IN ADDITION, HSLC PARTNERS WITH LOUDOUN COUNTY ANIMAL SERVICES AND LOUDOUN INTERFAITH RELIEF TO OPERATE A PET FOOD PANTRY FOR LOW INCOME RESIDENTS WHICH DISTRIBUTED OVER 10,000 POUNDS OF PET FOOD TO NEEDY FAMILIES.
