The number and amount of the scholarships is based on the investment performance of the Carsner fund during the year. In addition, CCMH has a nursing alumni group from its former school of nursing. Once again, applications are submitted by the candidates and are reviewed by the nursing alumni. Two scholarships are granted to individuals currently in an RN education program. The amount of funding provided is based on the amount of donations received during the year for this purpose.
