CWWV also coordinates the West Virginia Housing Policy Group that conducted the necessary research and analysis to develop a comprehensive West Virginia Housing Policy Framework in September 2013.

The Purpose of the Housing Policy Framework is establish broad goals and direction related to the state's housing policy, and to assist in coordination between state agencies, between state and local government, and between the private and public sector. The Housing Policy Framework helps ensure that policy responses to West Virginia's housing issues are not piecemeal, but instead link together to form a cohesive and comprehensive strategy. CWWV is also the lead host of the West Virginia Housing Conference.

REVOLVING LOAN FUNDS

CWWV Home Ownership Revolving Loan Fund capitalized with funds received from NeighborWorks America since 1996. These funds are made available to the member organizations to provide their clients with homeowner opportunities, and existing home owner with renovations to address health and safety code violations. Since 2006 CWWV has invested \$3,142,000 finance new homeowners, and provided \$238,246 in rehab loans to existing homeowners.

CWWV Commercial Loan Fund has loan \$763,160 to its member organizations for Commercial business activities. Coalfield Development Corporation purchased a building containing 7 rental unit rental in Wayne, WV; the Housing Authority of Wayne County purchased the Urlings Building in downtown Wayne, WV renovation included 8 rental units on the second floor, and the commercial space into office's and a Coffee Shop. August Development Corporation developed the August Pines subdivision adjacent to the city of Fairmont, WV. Coalfield Development Corporation acquired the (old Corbin Factory Warehouse) in the West Moreland section of Huntington, WV converting it into the West Edge Factory containing a warehouse of reclaimed properties, an Art Place, and other development ventures. Nonprofit Capacity Building Initiative

CommunityWorks in West Virginia has launched the NonProfit Capacity Building Initiative. Despite all the training and technical assistance efforts by CWWV, West Virginia nonprofits in the housing field continue to "leave money on the table" because they do not have the capacity to apply for and manage funds, develop and complete projects, navigate the complex and ever-changing housing rules and regulations and develop organizational sustainability strategies. Because housing affordability and housing quality are significant challenges for nearly one-fifth of West Virginia households, strong and visible housing organizations are needed to meet the unique challenges of the State. This issue has been identified and examined by the West Virginia Housing Policy Work Group (a group of experienced colleagues representing federal, state, and local stakeholders within the housing industry). While developing the West Virginia Housing Policy Framework, the group researched and analyzed issues unique to the State, informed by a survey of 206

individuals in the housing field. Nearly all of the housing stakeholders who completed the survey indentified the need for technical assistance. The factors most frequently selected as inhibiting housing development were related to the lack of planning at the local level and a lack of recognition of the importance of housing as component of economic and community development. A series of recommendations were made, including expanding funding sources for the preservation and rehabilitation of existing housing stock; increasing access to capital and technical assistance to nonprofit housing organizations; and establishing a technical assistance program to provide consulting services in the areas of compliance, community development and financing, contract management, and marketing plan development

To address these recommendations, CWWV developed the Nonprofit Capacity Building Initiative (NCBI) so that member organizations will have the skills and expertise to successfully develop housing opportunities and support community development efforts throughout West Virginia. The goal of the NCBI is to build the capacity of State housing organizations for full utilization all federal and state funding available. The NCBI will provide the following specialized project development and technical assistance to 10 targeted Nonprofit Member Organizations to achieve immediate high impact: Senior Living Community Models Initiative

The Senior Living Project is a collaboration among groups and individuals working toward better and more affordable housing in West Virginia and toward better living for the state's growing elder population. The project is led by CommunityWorks in West Virginia and the West Virginia Partnership for Elder Living, Inc. CWWV and WVPEL intend to partner with three communities in West Virginia to provide technical and monetary assistance to become model senior living communities. A group of experts in affordable housing, housing development, finance, health and human services, and community development have prepared this project. Community Works in West Virginia and the West Virginia National Guard recently initiated a teaming partnership that will benefit the people in several areas of West Virginia who are being impacted by a shortage of high quality employment opportunities as well as family and individual housing.

BuildJobs Initiative

West Virginia's coal industry has seen production decline significantly over the past several years. The state produced 158 million short tons of coal in 2008, and output has fallen each successive year to an annual total of approximately 115 million short tons in 2014—a cumulative decrease of 27%. The short-term forecast calls for continued decline to approximately 104 million short tons in 2015 and contracting further to 98 million short tons in 2016.

PRIDE Community Services—located in Logan County—makes a positive impact on the lives of those in need by bringing together educational, financial, and human resources that support self-sufficiency. To address local and regional unemployment and assist individuals in coal-related positions and other “down-stream” industries that have been negatively affected by the decline in coal production, PRIDE developed the BuildJobs Initiative. This regionally-focused effort will provide job training in the construction trade which will lead to industry-recognized credentials; restructure the economy to focus on small business and local development; and create new jobs in the construction industry.

West Virginia Housing Conference 2016 -CWWV the lead sponsor in partnership with the WV Community Action Partnership; the WV Habitat for Humanity; the West Virginia Housing Development Fund and the WV Partnership for Elder Living, hosted The West Virginia Housing Conference. The conference attracts more than 350 housing advocates, lenders, developers, administrators and policy makers from the non-profit, public, and private sectors last year. The theme, Housing Our Future, featured over 70 workshops plus opportunities to learn and network with national, state, and local experts - from the nuts and bolts of housing development to funding tools and innovative models - this conference also
