Completed Van Voorhis trailhead enhancements to add canoe and kayak access to the Monogahela River: installed a dock and launch system designed for canoes and kayaks at the Van Voorhis trailhead.

4b (Code:) (Expenses \$ 28,903 including grants of \$) (Revenue \$)

Initiated a project to repair an undercut on the Deckers Creek Trail. The Deckers Creek trail is on a railroad right of way adjacent to the creek, in a steep canyon that occasionally experiences rockfall. A portion of the trail has weathering indicative of likely rockfall in the in the near future. A grant has been secured to repair this, and matching funds raised, allowing MRTC to activate the grant and begin repair process. The grant award, \$144,512, will be received as work is completed and bills submitted for reimbursement. MRTC expenses are an additional \$28,903 in matching funds for the project.

MRTC updated and printed a map of the Monongahela River Trails. These are available, free, at stores, restaurants and hotels adjacent to the trail and from the chamber of commerce.
