Part V, Line 2(3): As is common with related organizations managed by shared staff and utilizing shared resources, Enterprise Properties and its affiliate, CADCO, use an intercompany due to/from account to capture transfers and other transactions during the normal course of recordkeeping. The net decrease in Enterprise Properties' payable to CADCO in 2016 was \$586.
