In 2016, our staff guided more than 3,850 volunteer participants through Hunger Challenge events in 10 different cities. Those volunteers assembled packages of soy, vitamins, dehydrated vegetables, and rice - and prepared the food for shipment overseas. More than 750,000 meals were packaged and shared with missionary partners in Ghana, Iraq, and North Korea.

Our staff organized travel for 51 volunteer participants for the purpose of short-term missions during 2016. Family groups and individuals, as well as church and school teams traveled to work alongside missionary partners to provide medical care, assist with construction projects and facility repair, work with children in orphanage settings, teach English, feed people, provide mission office support, minister to refugees, and generally assist with the work of God's kingdom all over the world.

Our staff works with local people to provide discipleship and practical support. In some cases, they work with people in recovery from addiction. Our staff also facilitates local response to disaster relief efforts, as the need arises.
