The organizations's parent activities are mainly focused on training, supporting, and providing resources for the subsidiary chapters, who deliver program services. A total of 13 staff persons support over 5,900 volunteers. Staff also administers the scholarships for therapists program, which awarded 314 scholarships, as well as the Therapeutic Tricycle Program; which makes awards in all fifty states. Chapters reported an estimated 5,900 volunteers who provided 72,000 hours of community service. Chapters provided an estimated 2.2 million dollars in grants to programs. Additionally, chapters First Accomplishment provided more than 3,600 therapeutic bicycles to kids with disabilities; more than 30,800 since inception.
