THE EMERGENCY SHELTER PROGRAM IS AN INTENSIVE CASE MANAGEMENT SUPPORT PROGRAM OFFERED TO GUESTS AS PART OF THEIR STAY AT FAMILIES MOVING FORWARD. A FAMILY SERVICES COORDINATOR WORKS WITH EACH FAMILY TO DEVELOP A PERSONALIZED PLAN TO PRIORITIZE AND ADDRESS THE FAMILY'S MOST PRESSING NEEDS, SUCH AS INCREASING INCOME, BECOMING MORE SELF-SUFFICIENT AND INDEPENDENT, AND GAINING SAFE AND AFFORDABLE PERMANENT HOUSING. THEY ALSO IDENTIFY RELATED OBJECTIVES, LIKE GAINING ACCESS TO CHILDCARE, STABILIZING PHYSICAL OR MENTAL HEALTH CONDITIONS, AND ADDRESSING CREDIT ISSUES. THE NEXT EMERGENCY SHELTER PROGRAM SERVED 67 FAMILIES OF WHICH 37 (79%) MOVED INTO PERMANENT HOUSING. 61% OF HOUSEHOLDS INCREASED THEIR TOTAL INCOME FROM ENTRY TO EXIT.

THE TRANSITIONAL HOUSING PROGRAM IS A TRANSITIONAL SHELTER PROGRAM THAT HELPS INDIVIDUAL FAMILIES IDENTIFY AND OVERCOME THE ROOT CAUSES OF THEIR HOMELESSNESS. DURING A COURSE OF STAY AVERAGING SIX MONTHS, RESIDENTS AND STAFF WORK TOGETHER TO MEET PARENTING, EDUCATION, JOB, AND HOUSING-RELATED GOALS.

THE AFTERCARE PROGRAM IS A COMPREHENSIVE SYSTEM OF AFTERCARE DESIGNED TO MAKE SURE FAMILIES DO NOT RETURN TO HOMELESSNESS AFTER THEY LEAVE THE SHELTER ENVIRONMENT. AFTERCARE CONNECTS FAMILIES TO THE SERVICES AND SUPPORT THEY NEED TO REBUILD THEIR LIVES, INCREASE THEIR INCOMES AND MAINTAIN STABLE HOUSING. AFTERCARE PROVIDES CASE MANAGEMENT SUPPORT AND TRAINED PARTNERS AND VOLUNTEER SUPPORT TO ASSIST WITH PRACTICAL NEEDS AND CONTINUED LIFE SKILLS DEVELOPMENT SUCH AS BUDGETING, HEALTHY MEAL PLANNING AND PARENTING SKILLS. HELPING OUR FAMILIES BUILD THEIR SOCIAL SUPPORT NETWORK IS ALSO AN IMPORTANT PART OF THIS PROGRAM. THE BRANCHING OUT AFTERCARE PROGRAM PROVIDED CASE MANAGEMENT AND VOLUNTEER SUPPORT TO 47 FORMERLY HOMELESS FAMILIES. 99% OF PARTICIPANTS RETAINED THEIR HOUSING FOR AT LEAST ONE YEAR FROM SHELTER EXIT.
