1 Briefly describe the organization's mission:

The mission of the North Carolina Holocaust Foundation is: (1) to educate students in North Carolina public schools on the historical importance and the lessons learned from the Holocaust, (2) to remember and honor the liberators and Righteous Gentiles in the Holocaust, (3) to remember and commemorate those individuals who perished due to planned and systematic Nazi persecution, and (4) to reflect upon genocidal events happening around the world today and to call for action.

The Teacher Workshops consist of North Carolina public school teachers meeting with (1) a university professor to learn about European anti-Semitism, the events leading to the election of the Nazi Party in Germany, and the planned and systematic destruction of European Jewry, (2) a retired public school teacher to learn how to teach the Holocaust to middle and high school students, and (3) a Holocaust survivor to hear a first-hand account of his/her suffering and surviving the Holocaust. The overall themes of the Teacher Workshops are (1) to explain why the teaching of the Holocaust and the lessons learned from the Holocaust are relevant and important in today's world and (2) to provide teachers with the skills and methods to teach students to understand the Holocaust and to appreciate, rather than fear, differences among people.

The \$16,248.43 in expenses the NC Holocaust Foundation incurred in planning and conducting the workshops in 2016 include (1) hotel, honorarium, gas mileage reimbursement, and food expenses for the speakers and (2) the cost of copying material for teacher handouts. The NC Holocaust Foundation conducted a total of eight (8) teacher workshops in 2016 (locations were Greenville, Cullowhee, Chapel Hill, Rocky Mount, Raleigh, Salemburg, Pilot Mountain, and Concord). Travel expenses embedded within the \$16,248.43 totaled \$2,269.35 and will be reflected in Part IX, Line #17; see also Schedule O, pages 3 and 4.

4b (Code: THEATRE) (Expenses \$ 7,707.72 including grants of \$) (Revenue \$)

The NC Holocaust Foundation commissioned two organizations to perform two Holocaust-themed plays to middle schools and high schools. The Touring Theatre of North Carolina performs, "Let Your Children Tell." The play depicts the actual lives of four middle school-aged children who suffered in the Holocaust. Some of the children were killed in the Holocaust while others survived. In 2016, the play was shown at Reedy Creek Middle School (Cary), Early College High School of Forsyth (Winston-Salem), Kennedy High School (Winston-Salem), Northview IB Middle School (Statesville), and Queens University (Charlotte). In addition, the NC Holocaust Foundation commissioned Susan Stein to perform the one-act play, "Etty." "Etty" reflects the life of Esther "Etty" Hillesum, a Jewish woman who was murdered at Bergen-Belsen. In 2016, Susan performed the play at Rockingham Early College High School in Wentworth.

The \$7,707.72 in expenses the NC Holocaust Foundation incurred in paying for the performances included \$7,300.00 to the Touring Theatre of North Carolina, \$400.00 to Susan Stein, and \$7.72 for signage. There were no travel costs documented by the NC Holocaust Foundation as payments to the two organizations were made as a 'lump-sum.'

4c (Code: EXHIBITS) (Expenses \$ 6,679.25 including grants of \$) (Revenue \$)

The NC Holocaust Foundations owns 18 Holocaust-themed exhibits which travel to middle schools, high schools and public libraries in North Carolina. There are four "Dr. Seuss Goes to War" exhibits, two "Kindertransport" exhibits, one "Butterflies, Fences and Walls" exhibits, one "Triumph of Life" exhibit, one Simon Wiesenthal exhibit, one "Women in Resistance Exhibit," and eight "What They Could Carry" exhibits. The NC Holocaust Foundation engages four Regional Traveling Exhibit Coordinators to schedule and transport various exhibits in an assigned area in North Carolina.

The \$6,679.25 in expenses the NC Holocaust Foundation incurred in scheduling and transporting the exhibits in 2016 include honorarium, gas mileage reimbursement, and food expenses for the Regional Traveling Exhibit Coordinators as well as repairs made to the exhibits. Travel expenses embedded within the \$6,679.25 totaled \$3,421.70 and will be reflected in Part IX, Line #17; see also Schedule O, pages 3 and 4.
