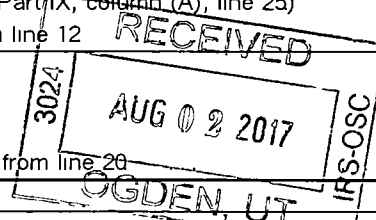

The conflict of interest policy is monitored by the President and Executive Director through a disclosure statement signed annually by all Officers, Directors, and Key Employees.
