However in 2014 the Organization was notified that it was a beneficiary of the Joseph Parker Estate. In 2014 the Organization recieved \$585,280 of publicly traded stock from the estate and in 2015 it received farm land valued at \$377,400 from the same estate. Being a small organization this was a blessing. however it reduced the public support percentageto less than 33 1/3%.

This contribution from the estate was a suprise. There are no restrictions with this contribution and there are no Directors related to the family of the estate. We do not believe that the organization should be treated as a private foundation since there was no influence on the organizations activities.
