COG will collect samples at diagnosis using special tubes (Streck tubes) which allow for the collection of circulating tumor DNA. The Streck tubes will be processed for plasma and white blood cells (WBCs) for future extraction of circulating DNA and tumor DNA, respectively.

Childrens National Health SystemThe study seeks to generate custom gene-fusion databases including all possible fusion events present in a tumors DNA. This database will be used to map all of the proteins that have been sequenced in the same tumor. Doing so will enable the team to assign protein fragments that do not correspond to the reference genome to disease-specific genomic structural variations, thereby validating those that are capable of effecting cellular change. By continuing this line of inquiry, the team aims to identify genetic events that transform normal cells into tumor progenitors including gene fusions and other structural variations leading to unique tumor proteins. In addition, they plan to leverage these unique tumor specific events to create assays to detect tumor DNA that is free floating in blood and cerebrospinal fluid. These personalized biomarkers could be used to monitor the effectiveness of therapy and detect early tumor recurrence at molecular resolution. Such a tool would allow an oncologist to precisely design a treatment regimen to avoid unnecessary toxicities while maintaining effectiveness.

This typically requires systemic chemotherapy affecting all parts of the body leading to unintended side effects. In the past recurrent metastatic neuroblastoma was treated with high doses of toxic chemotherapy requiring bone marrow transplant rescue due to the destruction of the patient's blood producing bone marrow. These unintended off-target toxicities are well known even with today's precision medicines. Some of these toxicities could be life-long. The ultimate goal of drug development is to find a way to deliver medicine selectively to tumor cells, and not to normal bone marrow, the immune system, kidney, or other vital organs. The team has recently developed a system whereby we can control drug delivery with such precision that toxicity only occurs where the drug is picked up by tumor cells. This Self-assembly/Disassembly (SADA) therapeutic is composed of a multimeric bispecific antibody (BsAb) fragments that can bind to surface antigens on tumor cells and radioactive payload. These BsAb fragments were engineered to spontaneously assemble into a multimeric SADA complex. Due to its multimeric nature, the SADA complex has enhanced cooperative binding (avidity) to the tumor target, increasing specificity to the target cells or tissues and extending initial serum half-life, while reducing non-specific binding to bystander targets and decreasing toxicity. At non-tumor sites, the SADA complex can spontaneously disassemble into smaller fragments which allow for rapid renal clearance from the body.
