All fundraising programs and services are conducted to support the charitable mission of Presbyterian SeniorCare and its affiliated tax exempt charitable organizations. Presbyterian SeniorCare is the sole member of numerous nonprofit membership corporations that provide a regional system of housing, personal care, Alzheimer's and dementia care, long-term and rehabilitation healthcare, and community services for older adults. Of note are its 28 affordable housing communities serving persons with disabilities and low-income seniors through a service-enriched model that supports aging in place and minimizes the need for institutional care. Presbyterian SeniorCare gives back to its local communities and provides charitable care to the seniors it serves who are no longer able to pay for their care. In 2016 across its regional network, it provided \$1,198,929 in community support and a combined total of \$20.4 million in benevolent and uncompensated care. The Presbyterian SeniorCare Foundation secures financial resources for places, programs and benevolent care, also known as charitable care. Its fundraising programs include special events, solicitations, major gifts as well as annual, memorial and planned giving. Programs are conducted as a comprehensive effort and include benevolent care, resident and staff enrichment, capital projects and capital equipment fundraising. In 2016, the Presbyterian SeniorCare Foundation secured \$1,195,000 in planned gifts and raised nearly \$175,000 for benevolent care through its two annual signature efforts - the Golf Outing at Oakmont Country Club and the "Your Holiday Home" event in Washington county. It also became the beneficiary of a \$1.2 million family trust. Additionally, to reinforce the Presbyterian SeniorCare Network reputation as a Dementia Care Center of Excellence, the Presbyterian SeniorCare Foundation hosted The Silver Factory Experience event which acknowledged the 25th anniversary of the introduction of Woodside Place of Oakmont, one of the first dementia-specific residential communities of its kind in the U.S., which has been replicated nationally and internationally in senior living and remains the basis upon which person-centered dementia care is delivered across all Presbyterian SeniorCare services, programs and communities. This awareness-building effort also helps to set the stage for the development of Woodside Place of Washington, which will be the first free-standing residential community specializing in dementia care in Washington county. In 2016, the Presbyterian SeniorCare Foundation conducted a feasibility study to establish its capital campaign goals and strategies in an effort to minimize the amount of debt necessary for the construction of this \$9 million dementia care community so that adequate resources remain available to support charitable care and services into the future in accordance with the heritage of Presbyterian SeniorCare. The Presbyterian SeniorCare Foundation secured a \$1,000,000 grant in 2016 from the Redevelopment Assistance Capital Program (RACP), which will be used to complete the final phase of renovations at the Willows skilled nursing community in Oakmont to support the transformation of the physical space to a home setting that adheres to the organization's person-centered and hospitality standards. In keeping with its goal of building relationships among donors, funders and affinity organizations, the Presbyterian SeniorCare Foundation partnered with 21 Voices on fundraising events to support Alzheimer's awareness and with local schools on iPod drives for the Music and Memory programs that are integral to the Woodside dementia care model used across Presbyterian SeniorCare. Additionally, Presbyterian SeniorCare Foundation coordinated the awarding of the Presbyterian SeniorCare Community Awards. 2016 awardees: Judith Saxton, PhD, Presbyterian SeniorCare Network Presents The Samuel K. The Presbyterian SeniorCare Foundation integrated two new Presbyterian SeniorCare affiliates into its network-wide 2016 fundraising plans and solicitation efforts. In March 2015, the Commonwealth of Pennsylvania Attorney General's Office reviewed and had no objection to the affiliation of Presbyterian SeniorCare and Presbyterian Homes of Lake Erie. In January 2016, the Commonwealth of Pennsylvania Attorney General's Office reviewed and had no objection to our affiliation with Shenango Presbyterian SeniorCare in New Wilmington, PA.
