Elpis Enterprises is only one of a very few agencies in the metro Twin Cities area that provides both a paid work experience and employment readiness training specifically designed to meet the unique needs of young people between 16 and 23 years of age who are homeless or at risk of being homeless. Elpis Enterprises operates social enterprises to provide this paid work experience and employment readiness training. Elpis three social enterprises are: a) customized screen printing (e.g., t-shirts & other textiles and mugs) b) manufactured wood products (i.e., bird feeders, nesting boxes & compost bins from donated recycled wood) c) e-commerce (a relatively new enterprise with the initial focus on screen printing). Additionally, Elpis trainees lead 120 to 150 community-based experiential screen printing and woodworking workshops reaching 3,000 or more individuals each year with most being school-aged youth. Across the enterprises, Elpis has 500 customers and an 80% customer retention rate. Elpis employment readiness training program is a self-paced and emphasizes a hands-on learning approach. It respects the trainees' developmental needs and often limited formal education. Trainees are on site Mondays through Fridays for 20 hours per week. This provides them time to continue their education (e.g., complete their GED, attend technical training classes) and pursue post-Elpis training plans (e.g., job search). With most trainees completing the program in three to six months, this represents 240 to 480 hours of training. Trainees learn technical skills while developing employment readiness and life management skills as they work side by side with enterprise coordinators who provide individualized coaching and mentoring. All enterprise coordinators are Elpis graduates.

Accomplishments: Since 2013, 50% to 70% of trainees each year upon exiting Elpis obtain employment paying \$10 or more an hour and 100% make progress on their educational plans. Additionally, with growth in enterprise sales, Elpis has increased the number of trainees it hires each year from 10 in 2012 to 25 in 2016. The number of agencies referring young people who are homeless or precariously housed to Elpis has increased from 1 in 2012 to 10 in 2016.
