In 2011, the facility performed over 3,300 operations on over 2,100 patients. It is the only facility of its kind in the area; the nearest comparable option is more than five hours away in Phnom Penh. In 2010 and 2011, the facility treated 112 surgical emergencies related to landmines and unexploded ordinance (UXO) more than 35% of an estimated 400 non-fatal casualties nationwide.
