Youth Leadership Network. Student Sponsorship Program.

This program is in Kenya works with 35 students throughout 2016. The kids range in age from eight to twenty-one and would have no other way to pay for school fees and related costs were it not for this program. These students show promise and dedication to their studies. The goal of the program is to see students achieve a full high school education and we have several now who have reached that goal and are continuing on in college / university. The majority of these students are in boarding school to provide proper shelter for a safer place to live and learn. This program is also providing shelter for several students and medical costs as they arise. The program also hosts annual retreats for the boys and girls to provide life-skills education, connection with other participants and a place to grow, share and develop into responsible and knowledgeable young adults

Kenyan Women's Network:

Our women's cooperative program is our largest program in terms of participants (partners). This program focuses on the social and economic empowerment of women living in extreme poverty in Kenya. Major accomplishments in 2016 include partnering with 3 new cooperatives, made up of 81 women living in western Kenya. Each woman attends 6 months of education to increase basic knowledge of critical life-skills through training in human rights, leadership and personal development, basic livelihood knowledge through business skills and bookkeeping education & improving overall health and nutrition levels through training in personal hygiene, basic nutrition and reproductive health. Following the 6-months, each group enters the small business growth phase to improve income levels and overall living standards. We partner with each group for a period of 3-5 years after the initial six-month training period. This includes revolving funds for small business growth, monthly monitoring, follow-up workshops and business coaching. We had a total of 19 groups / roughly 580 women in this program in 2016

Youth Leadership Network: Young Women's Leadership Challenge (YWLC) - U.S. Houston Area

This program provides an opportunity for high school aged young women to learn about themselves, develop leadership skills and understand their ability to improve not only their own lives but the lives of others. This is a year-round program that begins with a 6-day conference. As the capstone of the conference, they create their own personal Take Action Challenge that they will plan, implement and execute during the following school year. We provide follow-up meetings and check-ins to help them along their path. 2016 had 21 participants at the conference, joining roughly 110 alumni of the program. Topics covered in the conference include: Global Issues, Leadership, Self-esteem and Body Image, Financial Literacy, Careers and Conflict Resolution. A host of speakers come daily from different careers and backgrounds to share their stories. We serve at the Houston Food Bank together and also provide self-defense class for the young women. It was hosted at Rice University for the 4th year in a row.

All program activities conducted at the local level in Kenya are monitored and reviewed by local Pangea staff, an outside accountant and by the Pangea Network HQ staff and Board. Monthly requisitions for funding are received from the Kenya office, reviewed and wired to cover that month's program and administrative expenses. A monthly review is conducted by the accountant in the region, reviewing receipts and expenses against budget and sends an actual expenditure report, along with bank statements that are then reviewed by the Pangea head office in Texas. Also, as required by Kenyan law, we have audited books for all Kenya accounts starting in 2015.

Program staff in Kenya do monthly monitoring of all active women's cooperatives and review financial statements and also do random site visits of their small businesses if they are in the revolving fund stage.

Pangea HQ staff visit the field office on an annual basis for site visits with staff to the women's cooperatives and student sponsorship students to ensure program execution, impact and efficiency. We also review all policies and procedures, conduct performance reviews, etc. Program Investments are \$39,894. These revolving funds are given to the cooperatives who have finished their six-months of trainings and are disbursed as revolving source of funds for the women to start and grow small businesses and increase income levels
