IT IS AN OPPORTUNITY FOR PHYSICIANS, HOSPITALS, CITY AND COUNTY GOVERNMENTS, AND OTHER COMMUNITY AGENCIES TO HELP EXISTING SAFETY NET CLINICS AND AGENCIES PROVIDE NEEDED CARE IN A WAY THAT IS COORDINATED, EFFICIENT, AND MORE EFFECTIVE THAN ANY SINGLE ENTITY COULD PROVIDE ALONE.
