

**Part III: Organizations Primary Exempt Purpose: The Belt Volunteer Ambulance Service is a Public Charity formed to provide no-cost or low-cost pre hospital emergency care and emergency ambulance transportation for residents of Belt and Eastern Cascade County, Montana.**

**Part III, 2016 Achievements: During 2016, BVAS provided medical care to 122 patients in our service area and the surrounding areas. All services were provided by volunteers who received no compensation for their services. BVAS purchased a new Stryker power cot and Power Load system to lessen physical strain on providers and to improve patient safety. BVAS conducted several regional training sessions where EMS personnel from surrounding areas were invited to participate. This training increases coordination of care among agencies for better patient care. BVAS also funded several training opportunities for providers at Symposiums throughout the State of Montana.**
