IN JULY 2016, THE ORGANIZATION BEGAN PARTICIPATING IN THE LET'S INVEST FOR TOMORROW (LIFT) DOWN PAYMENT LOAN/GRANT PROGRAM WITH NEIGHBORWORKS AMERICA. THE ORGANIZATION PERFORMS EDUCATIONAL INFORMATION SESSIONS WITH MORTGAGE LOAN APPLICANTS TO DETERMINE IF THEY MEET THE 80% AREA MEDIAN INCOME AND OTHER QUALIFICATIONS TO RECEIVE A FORGIVABLE NON-AMORTIZING LOAN TO PURCHASE A HOME IN RICHLAND AND LEXINGTON COUNTIES IN SOUTH CAROLINA. FORGIVABLE NON-AMORTIZING LOANS RANGE FROM \$2,500 TO \$7,500 AND ARE FORGIVEN 1/3 EACH YEAR OVER 3 YEARS. THE ORGANIZATION IS PERMITTED TO CHARGE THE GRANT \$1,400 PER EACH LOAN CLOSED PLUS \$285 IN FEES TO THE BORROWER AT CLOSING DURING THE PERIOD FROM AUGUST 1, 2016 THROUGH DECEMBER 31, 2016.
