MANY SENIORS ARE LIVING ON LESS THAN \$800/MO. AND MAY BE DEFICIENT IN MEETING FOOD, MEDICINE, AND HOUSING EXPENSES. THE DAILY FOOD PANTRY IS OPEN 5 DAYS A WEEK AND SERVES CLIENTS THAT MEET INCOME AND PROGRAM GUIDELINES. CLOTHING VOUCHERS ARE ISSUED TO CLIENTS WHO MEET INCOME GUIDELINES AND ARE IN NEED OF CLOTHING. OUR PROGRAM GUIDELINES STATE THAT CLOTHING VOUCHERS CAN BE PROVIDED UP TO 4 TIMES A YEAR, TYPICALLY DURING SEASONAL CLIMATE CHANGES.
