SINCE 1989, THE COASTAL CONSERVATION LEAGUE HAS BEEN PROTECTING THE SOUTH CAROLINA COASTAL PLAIN - ITS NATURAL LANDSCAPES, ABUNDANT WILDLIFE, CLEAN WATER, AND QUALITY OF LIFE - BY WORKING WITH CITIZENS AND GOVERNMENT ON COMPREHENSIVE SOLUTIONS TO ENVIRONMENTAL CHALLENGES. OUR STAFF WORKS THROUGH FOUR MAIN PROGRAM AREAS: LAND & COMMUNITIES, FOOD & AGRICULTURE, AIR, WATER, & PUBLIC HEALTH, AND ENERGY. THE CONSERVATION LEAGUE WORKED TIRELESSLY AND EFFECTIVELY IN 2016 TO ENSURE THAT OUR WORK ADDRESSED THE MOST PRESSING CONSERVATION THREATS FACING THE SOUTH CAROLINA COAST - FROM PROMOTING GROWTH IN CLEAN ENERGY GENERATION (LIKE SOLAR) TO HALTING SUBURBAN SPRAWL (AND ROADS THAT FACILITATE IT). IF LEFT UNMET, THESE CHALLENGES WOULD SEVERELY COMPROMISE OUR ENVIRONMENT - ELIMINATING FARMS AND FORESTS, DEGRADING OUR RIVERS, CREEKS AND WETLANDS, POLLUTING AIR IN OUR CITIES, AND JEOPARDIZING THE HEALTH OF OUR CITIZENS. DURING THE PAST YEAR, WE ACCOMPLISHED NOTABLE VICTORIES AND MOVED MANY PROJECTS FORWARD. HIGHLIGHTS OF PROGRAMMATIC SUCCESS FROM 2016 INCLUDE: FOOD & AGRICULTURE: GROWFOOD CAROLINA, OUR LOCAL FOOD HUB, EXCEEDED THE 2016 SALES GOAL AND EXPANDED OUR LOCAL FOOD SUPPLY RADIUS TO THE ENTIRE STATE. INVENTORY NOW INCLUDES FRUIT, VEGETABLES, NUTS, GRAINS, DAIRY, EGGS, AND CANOLA OIL.

ENERGY: THE CONSERVATION LEAGUE PLAYED A KEY ROLE IN PASSING LEGISLATION AND CRAFTING REGULATIONS THAT SPURRED TREMENDOUS GROWTH IN ROOFTOP SOLAR PHOTOVOLTAIC INSTALLATIONS IN 2016, MAKING SOUTH CAROLINA A REGIONAL LEADER IN DISTRIBUTED RENEWABLE ENERGY ADOPTION. AT THE LOCAL LEVEL, WE SUCCESSFULLY COLLABORATED WITH JASPER COUNTY TO CREATE A SOLAR OVERLAY DISTRICT THAT FACILITATES THE CONSTRUCTION OF ONE OF SOUTH CAROLINA'S LARGEST SOLAR FARMS. THE CONSERVATION LEAGUE COLLABORATED WITH PARTNERS TO SHAPE SOUTH CAROLINA'S FIRST EVER STATE ENERGY PLAN, AND ENSURED THAT UPCOMING STATE ENERGY OFFICE PLANNING EFFORTS WILL FOCUS ON ENERGY EFFICIENCY AND RENEWABLE ENERGY OPPORTUNITIES AND BEST PRACTICE RESOURCE MODELING.

LAND & COMMUNITIES: THROUGH A COLLABORATIVE INITIATIVE BETWEEN INDUSTRY AND CONSERVATION, THE CONSERVATION LEAGUE WORKED TO PROTECT MORE THAN 2,500 ACRES IN FOUR HOLES SWAMP, A NATIONAL ECOLOGICAL TREASURE OF BLACK WATER SLOUGHS AND BALD CYPRESS AND TUPELO GUM WETLANDS. STAFF WORKED ON AN AGREEMENT WITH VOLVO TO RESTORE AND PROTECT 2,458 ACRES OF THIS IMPORTANT AREA, AND WITH WASTE MANAGEMENT (THE OWNER OF THE OAKRIDGE LANDFILL IN DORCHESTER COUNTY) TO SUPPORT THE PROTECTION OF MORE THAN 200 ACRES OF THE SWAMP, AS WELL AS UPLANDS IN THE EDISTO RIVER BASIN. WORKING WITH MEMBERS OF THE COMMUNITY, THE CONSERVATION LEAGUE THWARTED EFFORTS TO ADD MORE COMMERCIAL DEVELOPMENT TO THE ASHLEY RIVER HISTORIC DISTRICT BY ADVOCATING FOR REGULATIONS THAT RESTRICT FUTURE COMMERCIAL DEVELOPMENT NEAR THE DISTRICT. CONSERVATION LEAGUE EFFORTS TO PROMOTE SAFE AND ACCESSIBLE BICYCLE AND PEDESTRIAN INFRASTRUCTURE WERE EXTREMELY SUCCESSFUL IN 2016. WE ENGAGED MORE THAN 200 PEOPLE TO ADVOCATE FOR A LEGARE BRIDGE BICYCLE AND PEDESTRIAN LANE ACROSS THE ASHLEY RIVER - CONNECTING WEST ASHLEY AND THE CHARLESTON PENINSULA FOR CYCLISTS. ALSO INCLUDED IN THIS ADVOCACY WORK WAS SUPPORTING THE CREATION AND PROMOTION OF THE BERKELEY-CHARLESTON-DORCHESTER COUNCIL OF GOVERNMENT'S "BIKE-PED-BCD" PLAN, WHICH WILL SERVE AS A CATALYST FOR MYRIAD MULTI-MODAL INITIATIVES IN THE REGION. FURTHER, THE CONSERVATION LEAGUE WAS INSTRUMENTAL IN SUCCESSFULLY INCORPORATING A MULTI-USE PATH ALONG THE MAYBANK HIGHWAY ROAD IMPROVEMENTS ON JOHNS ISLAND. THIS PATH IS THE FIRST OF MANY WE WILL INCORPORATE IN ROAD IMPROVEMENTS AND PROVIDES NECESSARY, SAFE ACCESS FOR THOSE ON FOOT AND BIKE TRAVELING FROM JAMES ISLAND TO JOHNS ISLAND AND VICE VERSA. WORKING ALONGSIDE THE SEA ISLAND CORRIDOR COALITION IN OUR SOUTH COAST OFFICE, STAFF CO-HOSTED A FORUM ON FUTURE GROWTH ON LADY'S ISLAND. RENOWNED PLANNER VICTOR DOVER SPOKE TO A STANDING ROOM ONLY CROWD OF NEARLY 400 ABOUT HOW TO PLAN FOR GROWTH IN BEAUFORT COUNTY. THE LEAGUE IS IN THE PROCESS OF PUBLISHING A REPORT AND INCORPORATING RECOMMENDATIONS INTO THE COMP PLAN PROCESS.

AIR, WATER & PUBLIC HEALTH: CONSERVATION LEAGUE STAFF WORKED WITH PARTNERS AND ELECTED OFFICIALS TO PASS SENATE BILL 139 AT THE STATE LEGISLATURE - ESTABLISHING A PERMANENT BASELINE ALONG SOUTH CAROLINA'S COAST BY THE END OF 2017. THIS LAW PROHIBITS ANY CONSTRUCTION FROM OCCURRING SEAWARD OF THE LINE IN PERPETUITY - PROVIDING THE STRONGEST PROTECTIONS FOR SOUTH CAROLINA'S BEACHES IN 25 YEARS AND PREVENTING DEVELOPMENT OF FRAGILE COASTAL LANDSCAPES LIKE CAPTAIN SAMS SPIT AND BAY POINT ISLAND. IN AN ONGOING EFFORT TO PROTECT COASTAL WATERWAYS AND MARINE LIFE FROM PLASTIC POLLUTION, THE CONSERVATION LEAGUE WORKED WITH CONSERVATION PARTNERS, THE FOLLY ASSOCIATION OF BUSINESSES, AND FOLLY BEACH CITY COUNCIL TO PASS THE SECOND PLASTIC BAG BAN IN THE STATE ON FOLLY BEACH. FOLLY'S ORDINANCE INCLUDES A BAN ON BALLOONS, POLYSTYRENE FOAM PLATES, CUPS AND CONTAINERS ON THE BEACH. THE BAN ALSO PROHIBITS SINGLE-USE PLASTIC BAGS, POLYSTYRENE COOLERS, AND POLYSTYRENE TO-GO CONTAINERS AT POINT OF SALE WITHIN FOLLY'S MUNICIPAL BOUNDARIES. WE ALSO LED AN EFFORT TO PREVENT INFRINGEMENT ON HOME RULE BY SUCCESSFULLY DEFEATING A BAN ON BANS BILL IN THE LEGISLATURE, AIMED AT LIMITING LOCAL MUNICIPALITIES' AUTHORITY TO PASS THESE BANS. CONSERVATION LEAGUE STAFF WORKED TO SUCCESSFULLY PROTECT ONE OF THE LAST UNDEVELOPED MARSH HUMMOCK ISLANDS, 104-ACRE PAPPY'S ISLAND SITUATED IN THE CAPE ROMAIN NATIONAL WILDLIFE REFUGE, LAST SPRING AFTER THE PROPERTY OWNER BEGAN TO SEEK PERMITS FOR A PRIVATE, RECREATIONAL DOCK.
