SEE SCHEDULE ODURING THE 2016 FISCAL YEAR, SCOCF PROVIDED THE FOLLOWING PATIENT SUPPORT ACTIVITIES THROUGHOUT SOUTH CAROLINA We provide "Bags of Hope" to newly diagnosed patients Each black canvas bag is packed with a number of items for the woman undergoing chemotherapy and is delivered by an ovarian cancer survivor who offers a word of encouragement and an introduction to SCOCF During 2016, we spent \$2,053 to purchase new supplies for the bags and distributed 36 Bags of Hope Knowing that families often face new financial challenges following an ovarian cancer diagnosis, the South Carolina Ovarian Cancer Foundation stands ready to assist with \$100 Walmart gift cards, which can be used for food, gas, prescriptions or other immediate needs Our standard policy in 2016 was to provide a woman up to \$1,000 in this type of assistance per year during the time she was in active treatment In 2016, we provided \$3,100 in Walmart gift card assistance to 9 different ovarian cancer patients BI-LO gift cards were provided in December to cover the cost of a fully-prepared family dinner In 2016, we spent \$3,760 to give BI-LO cards to 40 women Each woman was contacted personally to offer her of the support and a \$100 card was mailed to her home BI-LO graciously offered a volume discount on the purchase of the cards Survivor groups in the Upstate and Charleston areas are invited to monthly "Lunch Bunch" support group meetings at local restaurants or other meeting places SCOCF pays for the cost of the lunches and an annual holiday lunch or dinner for each group In 2016, \$2,524 was spent for the Upstate survivors (a total of 213 meals) and \$1,732 was spent on Charleston area survivors (a total of 81 meals) A Christmas dinner was held in Greenville, SC at a cost of \$1,881 All survivors and board members were invited to bring a guest for this end-of-year event that recognizes volunteer efforts and celebrates survivorship Throughout the year, we conducted speaking engagements for employee and women's groups, and participated in women's conferences, health fairs and other events throughout the state to improve awareness about the signs and symptoms of ovarian cancer In September, which is ovarian cancer awareness month, we carried out an awareness campaign called "Turn the Towns Teal" throughout the state Women gathered to decorate city squares, college campuses, and even shopping centers in teal ribbons, turned public fountain waters teal (with permission, of course) and visited local businesses to share business cards printed with warning signs of ovarian cancer Turn the Towns Teal activities were carried out in 20 South Carolina locations Turn the Towns Teal ribbon and special awareness supplies, including fountain dye, were provided at a cost of \$1,155 In addition, SCOCF hosted a popular and exciting fundraising event, Handbags for Hope, on September 23rd Handbags for Hope is a silent and live auction that was held for the tenth year in 2016 Attendance was about 325 and net proceeds from Handbags for Hope, 2016 came to \$42,617 We participated as an organizing partner in the Dragon Boat Upstate Festival to benefit clinical trials and research being conducted right here in South Carolina for the treatment of ovarian cancer SCOCF funded two teams, O'Very Good Boat, and Sarah's Sailors/SCOCF at a cost of \$9,428 Team members raised additional funds as they garnered support to paddle in the Dragon Boat races After proceeds were distributed by the lead organizer Greenville Health System, SCOCF netted \$61,770 On 12/12/16, a donation of \$20,000 was made to the Greenville Health System Office of Philanthropy and Partnership, with specification that the funds are to be used for ovarian cancer research
