WILHEIT SERVICES PROVIDE FREE THERAPEUTIC SERVICES FOR STUDENTS IN THE GAINESVILLE CITY AND HALL COUNTY SCHOOL SYSTEMS. MENTORS RECEIVE A TWO-HOUR TRAINING SESSION AND A BACKGROUND CHECK. ONCE TRAINED, THE MENTOR CHOOSES THE SCHOOL OR CLUB IN WHICH THEY WOULD LIKE TO SERVE. PROGRAM EVALUATIONS ARE CONSISTENTLY POSITIVE AND DEMONSTRATE STUDENT IMPROVEMENT. OVER 400 STUDENTS WERE SERVED DURING 2016. EDUCATION CENTER POINT'S RELIGIOUS EDUCATION PROGRAM PROVIDES FREE ELECTIVE COURSES IN ACADEMIC RELIGIOUS STUDIES TO STUDENTS AT GAINESVILLE HIGH SCHOOL.
