With the Society of American Foresters and U.S. Forest Service, NAUFRP finalized a report in December 2016 Increasing Talent through Increasing Diversity (posted on web page). This was the first phase of a joint effort focused on diversity and inclusion issues within the profession. Funding is being sought for a second phase. Two members of the Executive Committee served as NAUFRP representatives on the Blue Ribbon Commission on Forest and Forest Products Research and Development. The Commission was formed under the auspices of the U.S. Endowment for Forestry and Communities (http://www.usendowment.org/) and was created to review the state of research in the forest sector.
