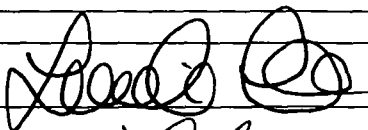
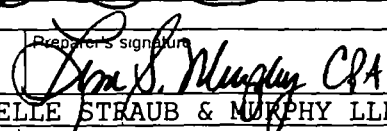

THE COMMUNITY FOUNDATION IS THE ONLY FUNDING SOURCE THAT REACHES ALL TYPES OF CHARITIES ACROSS THE OUTER BANKS, SUPPORTING PROGRAMS IN THE ARTS, EDUCATION, HEALTH AND HUMAN SERVICES, HISTORIC PRESERVATION, THE ENVIRONMENT, AND ANIMAL SERVICES. THE COMMUNITY FOUNDATION AWARDED MORE THAN \$700,000 IN GRANTS AND SCHOLARSHIPS IN 2016 TO 83 NONPROFITS AND 80 LOCAL STUDENTS.
