The organization has adopted investment and spending policies for endowment assets that attempt to provide a predictable stream of funding to support the assistance of Dominos Pizza team members while seeking to maintain the purchasing power of the endowment assets. Endowment assets include those assets of donor-restricted funds that the organization must hold in perpetuity. Under this policy, as approved by the Board of Trustees, the endowment assets are invested in the Multi-Asset Fund of the TIFF Investment Program. To date, the earnings on the endowment funds, which have no purpose restriction, have been reinvested in the TIFF account for future need. The endowment funds have been kept intact, and additional funds have been added through further fundraising efforts. This is consistent with the organizations objective to maintain the purchasing power of the endowment assets held in perpetuity as well as to provide additional real growth through new gifts and investment return.
