GraceWorks hosted 70 church/school groups here in Alaska this summer during our 8 week campaign 882 volunteers plus about 35 volunteer staff. We worked concurrently in 11 local parks five days a week, all summer long. We shared the God's love and the Gospel through our actions and through our words. We served almost 14,000 meals to disadvantaged children in the local parks here. We hosted about 80 community park parties complete with bounce house and free food served. Other projects included our Iditarod mission in Fairbanks and several Native village projects
