AND HAVE A SUBSTANTIAL ECONOMIC AND CULTURAL IMPACT IN THE BAY AREA. THE FOUNDATION STRIVES TO BE THE LEADING PROPONENT OF JAZZ ENTERTAINMENT THROUGH THE ANNUAL PRESENTATION OF THE CLEARWATER JAZZ HOLIDAY, A FOUR-DAY AND FOUR-NIGHT, WORLD-CLASS, LIVE MUSIC FESTIVAL, ENJOYED BY OVER 30,000 PEOPLE THE THIRD WEEK OF EVERY OCTOBER AND NOW IN ITS 38TH YEAR. (CONTINUED ON SCHEDULE O) THE FESTIVAL HAS EVOLVED FROM A SERIES OF CONCERTS ON THE BACK OF A FLATBED TRUCK AND AT VENUES AROUND THE CITY OF CLEARWATER INTO AN ANNUAL, INTERNATIONAL MUSIC FESTIVAL THAT DRAWS TENS OF THOUSANDS OF VISITORS EACH YEAR TO BEAUTIFUL COACHMAN PARK IN CLEARWATER. TOURISM IS A KEY COMPONENT OF CJH'S MISSION. CJH HAS HAD GREAT SUCCESS WITH CONCENTRATED MARKETING PLANS HIGHLIGHTING THE FESTIVAL AND PINELLAS COUNTY AS A POPULAR TOURIST DESTINATION. THE FOUNDATION ALSO STRIVES TO BE THE LEADING PROPONENT OF JAZZ EDUCATION. THE FESTIVAL EXPOSES THOUSANDS EACH YEAR TO JAZZ PROGRAMMING. HOWEVER, THE FOUNDATION ALSO HAS SEVERAL OTHER INNOVATIVE, EDUCATION INITIATIVES MAKING A HUGE IMPACT IN THE COMMUNITY AND THE LIVES OF YOUNG PEOPLE AND INCREASING CULTURAL AWARENESS. THE FOUNDATION IS PERHAPS MOST PROUD OF ITS POPULAR EDUCATION OUTREACH PROGRAM, REACHING THOUSANDS OF BAY AREA MIDDLE AND ELEMENTARY SCHOOL STUDENTS, EDUCATING THEM ABOUT THE HISTORY OF JAZZ THROUGH A CREATIVE LECTURE / PERFORMANCE PRESENTATION AND BUILDING A NEXT GENERATION JAZZ AUDIENCE. OTHER EDUCATION INITIATIVES INCLUDE TWO ANNUAL MEMORIAL SCHOLARSHIPS, GRANTED THROUGH A PARTNERSHIP WITH THE PINELLAS EDUCATION FOUNDATION, THAT ARE PRESENTED TO GRADUATING HIGH SCHOOL SENIORS WITH STRONG BACKGROUNDS AND INTERESTS IN MUSIC, TUITION ASSISTANCE FOR YOUNG MUSICIANS THAT HELPS TO OFFSET EXPENSES RELATED TO ATTENDING RUTH ECKERD HALL'S PRESTIGIOUS JAZZ PROGRAMS, SUPPORT FOR SCHOOLS - CJH OFFERS FINANCIAL SUPPORT TO LOCAL MIDDLE SCHOOL BAND PROGRAMS / JAZZ ENSEMBLES, AREA HIGH SCHOOL BANDS THAT PARTNER WITH US THROUGH OUR CJH SCHOOL-GIVE-BACK FUNDRAISING PROGRAM, WHICH HIGHLIGHTS GIVING OPPORTUNITIES FOR SPECIFIC BOOSTER PROGRAMS DURING THE FESTIVAL, AND SCHOOLS PARTICIPATING IN THE YOUNG LIONS JAZZ MASTER SESSIONS, UNIQUE SERVICE LEARNING EXPERIENCES FOR HIGH SCHOOL AND COLLEGE STUDENTS AT THE FESTIVAL, THREE-COURSE BUSINESS OF MUSIC SEMINARS PROVIDED AT NO COST TO ST.
