In 2009, she conducted a compensation analysis using the following tools: Professionals for Nonprofits' "2008 Annual Salary Survey of Washington, DC Nonprofits" and "2008 Annual Salary Survey of New York Nonprofits." The review of these salary ranges were comparable with Atlanta salaries. It is more likely that the market rate of salaries would be higher, even if only the cost-of-living increases were factored in. Funds are not available at this time to perform a new survey.
