Training and Education The Center engaged nonprofit leaders and organizations in numerous ways over the past year through their statewide training program. The Center organized and conducted in-person workshops, regional forums featuring funding panels, and webinars. Additionally, the Center convened nonprofit organizations throughout the state for additional training opportunities at the joint annual conference, Positioned for Progress: Partner Development. The Center worked to strengthen the relationship between nonprofit organizations and philanthropic agencies through their work with the MS Association of Grantmakers. The Center co-created and circulated a statewide survey, co-hosted regional roundtable discussions, participated in national and regional meetings to determine future programming and developed a report to communicate opportunities for expanded collaboration between the two entities. The Center will continue building on this work to provide greater levels of support for the nonprofit community. Program Enhancement: The Center updated its signature training program, Excellence in Action (EIA), to include Professional Development as a recommended practice and key learning objective to help nonprofit organizations build greater capacity. The Center developed new training modules to support this enhancement to the program. The Center also initiated conversations with the MS Secretary of State's Office to acknowledge nonprofits who receive EIA designation issued by the organization. Discussions on this topic will continue until a formal agreement is reached.
