The faithful partnership of our supporters has allowed us to continue to strengthen and expand the church in the Iran region and beyond with the combined work with our partner organizations. In 2016, we served several thousand Persian-speakers in Christian ministry through Bible conferences, advanced Bible training, accredited distance learning programs, and our three-month Christian leadership course. This included developing our ministry to provide targeted Bible training, care, and counseling to a growing number women who have experience abuse or oppression. We also continued in 2016 to print and distribute Bibles, New Testaments, and children's Bibles in Persian. We also translated, published and printed four new titles in Christian literature for use in evangelism, Bible training, and Christian education. Seventy titles were reprinted. Our media department produced weekly Christian TV programming in Persian for women, children, Christian worship, and evangelism. These programs were broadcast on satellite TV and made available via the Internet. Lastly, in 2016 we provided advocacy and financial support for over thirty persecuted Christians and their families. We also partnered with various churches across Europe to assist them in outreach and integration of Persian-speaking refugees into their local communities.
