Forest monitoring of timber and recreation management activities in the Chattahoochee-Oconee National Forest are the heart of Georgia ForestWatch's programmatic activities. Our staff Forest Ecologist leads all forest monitoring efforts with our well-trained volunteer district leaders, conducting on-the-ground surveys of all Forest Service projects and making recommendations to improve those projects. For over 30 years, Georgia ForestWatch has worked to preserve, protect and restore the 867,510 acres of the Chattahoochee-Oconee National Forests in Georgia, and have helped address issues critical to North Georgia forests.

Another critical part of our mission is to educate the public about these unique forest lands and to empower citizen action on behalf of these special places. We engage people through outings, presentations, newsletters, and social media. Our outings focus on science, forest management activities, ecology, and having fun in the woods. By offering spring wildflower hikes, issue hikes, old-growth hikes, canoe trips and freshwater snorkeling opportunities, we help our members appreciate our forests and want to become advocates for forest protection. Our quarterly newsletter and electronic action alerts help update, inform, and engage our members and the public about issues in Georgia's national forests.

The third vital component of our mission is to help preserve wild and scenic areas and other special places in the Chattahoochee-Oconee National Forest for future generations. Getting special areas of a national forest permanently protected literally takes an act of Congress. ForestWatch is dedicated to having more areas in the Chattahoochee-Oconee National Forest protected as Wilderness, Scenic, Recreation and other designations, with the highest levels of protection (not allowing new road building and logging) in wilderness, roadless areas and wilderness study areas.
