Mission Based social enterprises to generate revenue to support local domestic violence shelter and services to women and children in West Yavapai County. 418333 of proceeds spent on Employment Enhancement and Opportunities Program. \$282672 of proceeds spent on Not For Profit Community Center and 12 Step Services Project. \$21407 of proceeds supported the operations of our local domestic violence shelter project.

Employment Enhancement Opportunities Program provided paid employment training & placement services to 19 women in our local domestic violence shelter and 48 community re-entry workers recently out of prison, drug/alcohol rehab needing transitional employment while preparing for community employment integration. Retail sales/POS systems, computer publishing, barista, library science are just a few of the employment training opportunities this program offers. Of those 67 people, 24 secured employment, 29 are still in the paid training program (2016 carry over) and 14 relocated out of the area and we have no information. Over 200 hours of personal growth and development training provided and paid for through this program.

Not-For-Profit Multi-Tenant Resource/Community Center 2016 Stats - 36 - 12 Step Self-Help meetings per week (640 people per week). 20 meeting/training events for other community based service organizations per week. Center is utilized by community based Not-For-Profits, civic groups and other service organizations an average of 10 hours per day, 7 days per week. Recovery & self-help library and bookstore provided over 4200 recovery based medallions, books, workbooks, tools to help people on their path toward healing and sobriety. Approximately 18 people per day came into the center to access the "wall of community resources", for brochures, applications and information on local community resources available to help. Over 800 hours provided by our community education department on community outreach and education programming to the public. As well as monthly educational and outreach materials published and provided to the community.
