Patriotism, good citizenship and fraternalism as interaction were also stressed during camp. A total of 105 youth attended.

A spring and fall encampment for senior citizens was held this year. The encampment offered recreational activities and entertainment for senior citizens. A total of 50 seniors participated in these encampments.
