

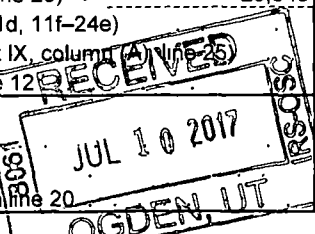

members of the Fund's eight-member Board of Directors (Lapidus, Balzer, Sobel, Rosenberg, Platt, and Hanson) also sit on the European

University's Board of Trustees and attend its meetings in June and December. Students who are U.S. Citizens or permanent residents may

apply for financial aid contingent upon their being accepted for full-time study in one of the graduate programs offered by the

background on the reasons for choosing the program, a copy of the applicant's application to the European University, and one letter of

recommendation. Applications are reviewed by the Fellowship Committee. Funds are awarded on the basis of academic performance and the
