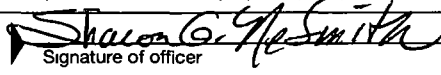

The Owensboro International Bar-B-Q Festival has two missions: to celebrate "Good ole Daviess County, Kentucky, Bar-B-Q", and to provide a forum for local not-for-profits to raise money. In addition to providing space for booths and activities for the not-for-profits, our board donates varying amounts based on available funds at the end of each annual Bar-B-Q Festival to not-for-profit groups nominated by that year's board members and to those groups who provided assistance during the Bar-B-Q Festival with activities or services.

Part III, Line 28: Donations to numerous community not-for-profits. \$14,750 in 2015.

In 2016, our International Bar-B-Q Festival fundraising event had gross receipts in excess of its expenses. In accordance with our mission, board members nominated many worthy not-for-profits to support with the portion of the event's excess receipts not earmarked to invest in future fundraising events. These not-for-profits included, among others, museums, high schools, middle schools, performing arts organizations, criminal justice organizations, and animal welfare organizations. We are proud to have provided \$14,750 to support these organizations and the people they serve in 2016.
