OurSpace World, Inc (DBA OurSpace Acupuncture) operates in Silver Spring, MD with a mission of ensuring community health through affordable, accessible acupuncture and local wellness partnerships. Using the community acupuncture model, OurSpace Acupuncture is able to provide safe, affordable, and effective healthcare to a large segment of the working class population. Clients give what they can afford - we suggest \$15-\$40. There is no application or income verification to ensure that people and families in high income brackets are not prohibited from accessing acupuncture due to other financial obligations. OurSpace World, Inc sees health and wellness in a holistic way and looks forward to providing other shared resources for health through partnerships including community supported agriculture, fitness/dance classes, and daycare services.

In its sixth year, OurSpace World Inc (dba OurSpace Acupuncture) has continued to provide community acupuncture services, providing 4,143 treatments (476 new client visits, and 3,667 returning client visits). Of these, 445 (up from 279 in 2015) were treatments given for free or for a subsidized amount (below our suggested \$15-\$40 donation range). For a portion of 2016, OurSpace employed administrative staff and also utilized a graduate-level intern to increase outreach efforts. OurSpace also cultivated a new partnership with Generation Hope, and treated 5 Generation Hope scholars, helping them manage stress and other health concerns to support them in completing degree coursework.

In 2016, OurSpace continued a Sustainable Food Project by partnering with the Lancaster Farm Fresh Cooperative, a non-profit organic farmer's cooperative of over 100 family farmers headquartered in Lancaster County, Pennsylvania. Managed and staffed entirely by volunteers, OurSpace became a host / pickup site for fresh, organic produce in the form of CSA (community-supported agriculture) shares. A total of 30 households picked up weekly vegetables and fruits from May through November over two seasons.
