Ecovillage Training Center: In conjunction with the United Nations Institute for Training and Research (UNITAR), Global Ecovillage Network and Gaia University, the Institute educates international students and transfers regenerative technologies through an immersion pedagogy of ecovillage living, classroom activity and hands-on skill-building, together with seminars, workshops, lectures, camps, films, practical demonstrations, publications, and outreach on six continents. In 2016 the program provided more than 50 public lectures and 10 extended workshops (including Belize, China, EU, Mexico, Morocco and UK), and produced numerous publications and course workbooks. For these purposes GVI maintains an office and training facility in Tennessee.

4b (Code:) (Expenses \$ 27255 including grants of \$ 22550) (Revenue \$ 25000)
Culture Change: The only realistic response to the "hyperwicked" problems of climate change, peak oil, population explosion and the converging limits to growth is not scientific or technological but cultural. Culture Change is GVI's project to chart a new course to the era after petroleum, a car-free, air travel-restricted world of renewable energy sail and rail. Among the projects GVI sponsors are the Sail Transport Network and the effort to reduce the use and disposal of petroleum-based plastics. An Internet-based journal, Culture Change, and a blog, The Great Change. For these purposes GVI maintains an office for the SAIL-Med project in Greece. This program also includes the Regenerative Development to Reverse Climate Change Initiative of the Secretary General of the Commonwealth of Nations, Cloudburst Foundation and Project Drawdown.

Marda Permaculture Farm: Global Village Institute operates a "Peace Through Permaculture" Initiative in Israel's West Bank with permission of the Palestinian Authority. Included in this program are courses of instruction in permaculture, drylands water management, farming apprenticeships, and natural building. This program is operated with the cooperation and assistance of the Permaculture Research Institute of Australia. For these purposes GVI maintains an office and training facility in Palestine.
