An Amendment to Plan A was adopted effective August 1, 2011, which terminated further accruals (contributions) to the plan. However, the Amendment allowed the accrual of interest on undistributed amounts which were subject to risk of forfeiture until such time as indicated in the Amendment. Interest earned by Plan A during 2016 was \$67,140 and is not required to be reported in compensation in Part II as Mr. Spezia is not vested in the 2016 earnings on Plan A. However, in 2016, Mr. Spezia vested in the Plan A previously untaxed earnings accumulated after July 31, 2011, through 2015. The total amount of \$352,567 has been reported in Col. B(III) of Schedule J, Part II as it became fully vested and taxable in 2016. Plan B was established in 2011. Employer contributions to Plan B during 2016 totalled \$34,000, which is reported in Col. C of Schedule J, Part II. Interest earned by Plan B during 2016 was \$67,349 and is not required to be reported in compensation in Part II as Mr. Spezia is not vested in the 2016 additions to Plan B. However, in 2016, he vested in the employer contributions and earnings that occurred from 2011 through 2015, for Plan B. The total amount of \$1,190,535 has been reported in Col. B(III) of Schedule J, Part II as it became fully vested and taxable in 2016. James VanderSteeg was a participant in a nonqualified deferred compensation plan, which will be referred to as Plan A.
