The Organization made a \$300,000 Business Development Loan to a member of the Board of Trustees which was approved by the Board and the Body at its annual Session, to fund a project to provide affordable burial facilities for its members in the rural areas of Alabama.

The member died in 2015 and the facilities and the debt was assumed by another member of the Organization. The member was not a member of the Board of Trustees and had no governing responsibilities.
