Hands On Birmingham (HOB) provides essential volunteer labor to several nonprofits and community organizations throughout Greater Birmingham, including Blount, Shelby, St. Clair and Walker counties. In 2016, HOB provided more than 16,281 hours of labor to support nonprofit and community organizations throughout Central Alabama. These hours were accrued through six major Days of Service and special projects: BCS Back To School Beautification, Project Homeless Connect, Dr. Martin Luther King Jr. (MLK) Day of Service, Family Volunteer Day, 9/11 Week of Service and Remembrance, United Way Day of Action, Bunny Aid, Back-to-School Backpack drive and community service referrals. Projects consisted of neighborhood revitalizations, park refurbishments, painting, landscaping, constructing community gardens and green spaces, cleaning creeks and rivers, nurturing children, and socializing with seniors. HOB recruited and managed 4386 volunteers in 2016.

Form 990, Part III, Line 4b:

Project Homeless Connect (PHC) is an annual event started in 2008, to address social, financial, hunger and health issues impacting the homeless community of Birmingham. Project Homeless Connect provides crucial services year-round, which climaxes with the annual PHC event held annually in March. In partnership with, One Roof, the City of Birmingham, Jefferson County Department of Health and over 40 community partner agencies and local businesses, anyone struggling with homelessness can attend PHC and receive any and all services available, free of charge, in one day. These services include anything from resources for housing and employment, a hot meal, resources to address hunger and nutrition, legal services, financial planning, haircuts, counseling, care kits, clothing and a plethora of healthcare services including, medical, dental and HIV testing. Hands On Birmingham's role in this event is to coordinate and train volunteers that serve as Smiling Faces Client Guides. These volunteers are paired one-on-one with each homeless client, to serve as their host and guide throughout their time at PHC. In 2016, over 1278 clients were served at PHC with 1600 volunteers directly paired with a homeless client. Without these volunteers, the event would not be a success year after year. PHC volunteers are instrumental to help increase the capacity of all the organizations providing services to the clients. HOB's goal is to guide the clients through the process and help them meander through a vast array of helpful services, treat them with the dignity and respect that they deserve and to make their day as seamless as possible by simply being a friend. Though services are provided in one day, these services help the homeless population across the continuum of their situation. HOB volunteers devoted 5600 volunteer hours to PHC.

Form 990, Part III, Line 4c:

Hands On Birmingham conducts one of the largest MLK Days of Service in the country among Hands On Affiliates. This service day has benefitted from a steady growth of volunteer engagement over the past eleven years. In 2016, 1600 volunteers participated in 28 service projects throughout Central Alabama. Volunteers from all walks of life, ages, genders and races worked together to make a positive impact in their communities. Other notable accomplishments for HOB include the assembly of 2400 Easter Baskets for homeless children through the Bunny Aid program, the distribution of 704 backpacks, donated by volunteers, to children in need. Lastly, Hands On Birmingham partnered with the City of Birmingham, the Bloomberg Foundation, Home Depot and Alabama Power to revitalize fifteen Birmingham neighborhoods through the Cities of Service initiative.
